REGULAR MEETING MINUTES TUESDAY, APRIL 19, 2022

APPROVAL OF PREVIOUS MINUTES

Manager Mills relayed that he had not had time to develop the minutes from previous meetings.

COMMUNICATIONS

Manager Mills reported that:

- There was a Kings County Export Ordinance meeting on April 18.
- Former General Manager of Panoche WD accused of stealing more than \$25 million of CVP water.
- A recent Bulletin 120 Forecast estimated the Kings River April-July runoff is 520,000 acrefeet, or 43% of average.
- He developed a support letter for a KRCD grant application for Land Repurposing.
- The Tulare Lake Subbasin 2021 Annual Report was submitted to DWR.
- The MKR GSA received well permit zip code information from Kings County as requested.

MANAGER'S REPORT

REVIEW OF GOVERNOR'S RECENT EXECUTIVE ORDER N-7-22

Manager Mills reported that the new EO included the following:

- May 2022 SWRCB emergency conservation regulations:
 - o Urban Water Supplier Water Supply & Demand Assessment by 06/01/22.
 - o Urban Water Supplier Water Shortage Contingency Plan.
- Suspension of CEQA on conservation projects.
- Suspension of prohibitions on hauling water out of basin of origin to truck emergency water for human consumption, cooking, or sanitation in communities or residences.
- New Ag and Industrial Well Permit requirements for GSAs and Counties.
- DWR directed to suspend CEQA requirements on grant funded recharge projects.
- DWR to prepare for multi-year transfer program pilot project to buy water and convey to "areas of need".
- DWR comes out with FACT Sheet on EO regarding well permits.

REVIEW OF KINGS COUNTY ATTESTATION EFFORTS

Manager Mills reported the following on the effort:

- Board of Supervisors approved a proposal to deal with their requirements. It involved recording a commitment from the land owner to comply with GSP/GSA requirements.
- The effort was reviewed by County Council and viewed as too much liability for the County. So progress there has currently stalled.

REVIEW OF OTHER LOCAL GSA WELL PERMIT VALIDATION EFFORTS

Manger Mills provided a brief description of how other nearby GSAs were dealing with the new GSA Verification process.

PROPOSED INTERIM MKR GSA WELL PERMIT VALIDATION

Manager Mills reported the following on the effort, as described in Resolution 2022-02:

- Review of the content of the WHEREAS statements in proposed Resolution Agency Understanding.
- Review of the ACTIONS authorized in the proposed Resolution
 - Contact each local municipal water supply system in the service area and request information
 - o Formal request to Kings Co for all well permit info from 01/01/22 to present to conduct an investigation into the current issues for municipal and domestic wells
 - o Immediately require all landowners in the service area to register active wells and provide WCRs if they exist
 - o Information will be provided to Kings County on GW conditions well permit applicants should be aware of
 - o GSA Verification provided if:
 - Replacement wells require submittal of WCRs if they exist

- ➤ Applicant/owner aware of "protect health, safety and the environment" requirement
- ➤ Applicant/owner aware of current and long-term groundwater conditions
- ➤ Provide location and info on any operable well within 1,000 feet of well site if available
- > Totalizing flowmeter required and allowance to enter property and monitor
- Throttling valve required, for use, if necessary during emergency declaration
- ➤ Applicant/owner aware that verification doesn't exempt app/owner from potential litigation from operational impacts
- County paragraph 9b process by Kings County:
 - ➤ Determination appears to be impossible prior to construction
 - Community systems are deep wells in our area and are do not appear to be at risk
 - ➤ If a replacement well is located in a similar location to the original well, impacts to other nearby wells will likely be similar
 - ➤ New ag/industrial wells located 660 feet from any other existing well owned by another party if possible and primarily perforated in a deeper zone than existing domestic wells
 - ➤ Subsidence has been an issue in this are for many decades. Recent Stanford modeling suggests legacy subsidence. The GSA doesn't know of any technical method to evaluate whether a proposed well would be likely to cause subsidence.

The Board discussed the proposed framework for GSA Verification with Manager Mills, asking various questions, giving opinions and providing some guidance on needed adjustments and the correction of minor typos. After the discussion, Vice-Chair Dias made a motion to approve Resolution 2022-02 with the discussed revisions and Director Sharp seconded the motion. Chair McCutcheon called for a vote, and the vote for all of the Directors was as follows:
